#### Latest News

- The House and Senate are in session this week. The Senate is expected to consider a continuing resolution to fund the government at current spending levels this week, which is expected to last until December 9. Sticking points over funding to combat the Zika virus, and disaster assistance for victims of the recent flooding in Louisiana and elsewhere have mostly been worked out, however discussions remain ongoing. Should the Senate approve a CR this week, they are expected to then adjourn until after the November elections, followed by the House.
- The House Homeland Security Committee will hear from Chiefs and representatives from the Major County Sheriffs' Association on Wednesday at a hearing to listen to their perspectives on what they see as the current security threats to the homeland, and what needs to be done to address these concerns.
- House Homeland Security Committee Counterterrorism Strategy On September 20, House Homeland Security Committee Chairman Mike McCaul, released a new nonpartisan counterterrorism strategy: A National Strategy to Win the War Against Islamist Terror. #### NFCA/E-ISAC RAPID DEPLOYMENT PROJECT ISE Blog | Fred Hintermister

On Dec. 23, 2015, substations on the Ukrainian power grid were systematically disconnected for three hours. Although not immediately known, the failures were later attributed to be the result of a coordinated, sophisticated cyber attack by a state actor with considerable technological resources. According to a report on the Ukraine incident published by the Electricity Information Sharing and Analysis Center (E-ISAC), the attackers demonstrated a variety of techniques to penetrate the Ukrainian power grid information technology network, including spear phishing emails, malware, and the manipulation of Microsoft Office document macros. Additionally, the attack included an on-site human element that was able to harvest credentials, map network connected infrastructure, and gain insight into the supervisory control system. **Continue reading here.** 

#### AP, Other Media Sue FBI for Details On iPhone Hacking Tool Associated Press | Eric Tucker

The Associated Press and two other news organizations sued the FBI on Friday to learn who the government paid and how much it spent to hack into an iPhone in its investigation into last year's San Bernardino, California, massacre. The lawsuit seeks records about the FBI's contract with an unidentified vendor who provided a tool to unlock the phone belonging to Syed Rizwan Farook, who with his wife killed 14 people at a holiday gathering of county workers in December 2015. Gannett Co., which owns USA Today, and Vice Media LLC joined the complaint with the AP, seeking to learn more about the mysterious transaction that cut short a legal dispute in which the government sought to force Apple Inc. to unlock the phone. **Continue reading here.**

#### Legislation on the Floor This Week

#### House:

#### H.R. 5963 - Supporting Youth Opportunity and Preventing Delinquency Act

**Status**: To be considered in the House on 9/20 **Summary**: To reauthorize and improve the Juvenile Justice and Delinquency Prevention Act of 1974, and for other purposes. Federal programs to prevent juvenile delinquency and provide services to young offenders would be reau-

thorized through fiscal 2022. The bill would authorize a total of \$855.2 million from fiscal 2018 through 2022 for state, local and American Indian tribal programs.

#### H.R. 6004 - MGT Act

#### Status: To be considered in the House on 9/20

**Summary**: This bill allows large federal agencies to obtain more financial support to update and improve their information technology (IT) and cybersecurity systems. The bill would establish IT modernization funds and create a board to oversee improvement projects. Funds could be used to replace legacy systems, move to cloud computing platforms, respond to cybersecurity threats, and procure IT products and services.

#### H.R. 5859 - Community Counterterrorism Preparedness Act

Status: To be considered in the House on 9/20

**Summary**: Emergency response agencies in major urban areas could receive grants from the Federal Emergency Management Agency for training and exercises to prevent, prepare for and respond to potential terrorist attack scenarios, including active shooters. The measure would authorize \$39 million annually for grants from fiscal 2017 through 2022.

#### H.Con.Res. 122 - PROTECT Patrimony Resolution

Status: To be considered in the House on 9/21

**Summary**: Congress would condemn the theft, illegal possession, sale, transfer and export of tribal cultural items. It would call on the heads of the Interior, State, Commerce, Homeland Security and Justice departments to consult with tribes and American Indian religious leaders to take action to stop illegal activity and secure repatriation. The measure would support the development of explicit restrictions on the export of tribal cultural items and encourage states, local governments and interested groups to work cooperatively.

#### H.R. 4712 - Strengthening the Department of Homeland Security Secure Mail Initiative Act

Status: To be considered in the House on 9/21

**Summary**: Recipients of documents under the Homeland Security Department's Secure Mail Initiative could require that the U.S. Postal Service obtain a signature when the document is delivered. DHS would have to require that a fee be paid, and that the amount of the fee be enough to cover the costs.

#### H.R. 5391 - Gains in Global Nuclear Detection Architecture Act

Status: To be considered in the House on 9/21

**Summary**: The Homeland Security Department's Domestic Nuclear Detection Office would have to document how the research it supports aligns with the high-level goals of a global program to improve nuclear detection architectures.

#### H.R. 5459 - Cyber Preparedness Act of 2016

#### Status: To be considered in the House on 9/21

**Summary**: This bill amends the Homeland Security Act of 2002 to expand the responsibilities of the Department of Homeland Security's State, Local, and Regional Fusion Center Initiative to include serving as a point of contact to ensure the dissemination of cybersecurity risk information within the scope of its information sharing environment with state, local, and regional fusion centers. (A fusion center serves as a focal point within the state and local environment for the receipt, analysis, gathering, and sharing of threat-related information between the federal government and state, local, tribal, territorial, and private sector partners.)

#### H.R. 5346 - Securing our Agriculture and Food Act

Status: To be considered in the House on 9/21

**Summary**: This bill amends the Homeland Security Act of 2002 to direct the Assistant Secretary for Health Affairs to carry out a program to coordinate Department of Homeland Security (DHS) efforts related to defending the food, agriculture, and veterinary systems against terrorism and other high-consequence events that pose a high risk to homeland security. Such program shall include: (1) providing oversight and integration of DHS activities related to veterinary public health, food defense, and agricultural security; and (2) leading DHS policy initiatives relating to food, animal, and agricultural incidents and to overall domestic preparedness for, and collective response to, agricultural

terrorism.

#### H.R. 5460 - First Responder Access to Innovative Technologies Act

Status: To be considered in the House on 9/21

**Summary**: This bill amends the Homeland Security Act of 2002 to direct the Federal Emergency Management Agency (FEMA) to implement a uniform process for reviewing applications that contain explanations to use grants provided under the Urban Area Security Initiative or the State Homeland Security Grant Program to purchase equipment or systems that do not meet or exceed any applicable national voluntary consensus standards developed under the Post-Katrina Emergency Management Reform Act of 2006.

#### H.R. 5065 - Bottles and Breast-feed-ing Equipment Screening Act

Status: To be considered in the House on 9/21

**Summary**: This bill directs the Department of Homeland Security to: notify air carriers and Transportation Security Administration (TSA) security screening personnel of TSA's 3-1-1 Liquids Rule Exemption guidelines allowing baby formula, breast milk, and juice on airlines; and include training on all special procedures under TSA's travel guidelines for TSA security screening personnel.

#### H.R. 5943 - Transit Security Grant Program Flexibility Act

Status: To be considered in the House on 9/21

**Summary**: To amend the Implementing Recommendations of the 9/11 Commission Act of 2007 to clarify certain allowable uses of funds for public transportation security assistance grants and establish periods of performance for such grants, and for other purposes.

### H.R. 5325 - Legislative Vehicle for the Continuing Resolution to Fund the Federal Government Status: Possible consideration in the House upon passage by the Senate

**Summary**: Details TBD: Expected to extend government funding at current levels until December 9, as well as include funding to combat the Zika virus, and provide disaster relief for Louisiana and other areas.

#### H.R. 5325 - Legislative Vehicle for the Continuing Resolution to Fund the Federal Government Status: Possible consideration in the Senate on 9/19

**Summary**: Details TBD: Expected to extend government funding at current levels until December 9, as well as include funding to combat the Zika virus, and provide disaster relief for Louisiana and other areas.

House Energy & Commerce Committee - Communications Subcommittee Markup - September 12

#### H.R. 2566 - Improving Rural Call Quality and Reliability Act of 2015

**Status**: Approved by the Communications Subcommittee on 9/12 **Summary**: Amends the Communications Act of 1934 to require an intermediate provider that offers the capability to transmit certain voice communications and signaling information from one destination to another, and that charges a rate to any other entity (including an affiliated entity) for the transmission, to: (1) register with the Federal Communications Commission (FCC), and (2) comply with service quality standards to be established by the FCC.

#### H.R. 2669 - Anti-Spoofing Act of 2015

**Status**: Approved by the Communications Subcommittee on 9/12 **Summary**: Amends the Communications Act of 1934 to expand the prohibition on the provision of inaccurate caller identification information (which makes it unlawful to cause a caller identification service to knowingly transmit misleading or inaccurate caller identification information with the intent to defraud, cause harm, or wrongfully obtain anything of value) to persons outside the United States if the recipient is within the United States. Revises the definitions of "caller identification information" and "caller identification service" to include text messages sent using a text messaging service.

#### Senate Armed Services Committee - Full Committee Hearing - September 13

#### **Encryption and Cyber Matters**

**Summary**: This hearing examined encryption and cyber issues as it relates to our national defense and military. Senator McCain expressed his opposition with proposals to separate the NSA and Cyber Command, due to Cyber Commands dependency on the NSA's capabilities. Despite this opposition, others believe that the separation should occur because the intelligence-gathering and combat functions have distinct targets and purposes. Additionally, Defense Department officials stated that they continue to support strong encryption to protect military capabilities and commercial encryption technology that is critical to U.S. economic security.

#### House Homeland Security Committee - Border Security Subcommittee Hearing - September 13 Moving the Line of Scrimmage: Re-Examining the Defense-In-Depth Strategy

**Summary**: This hearing examined the Border Patrol's Defense-in-Depth strategy, and the effectiveness of interior checkpoints as a border security tool. Some believe that the Defense-in-Depth strategy cedes crucial time and space to the drug cartels in the rural areas of the border by not apprehending individuals soon after they cross, instead using rugged terrain to wait hours and sometimes days to interdict illegal activities. As a result, populated rural areas adjacent to the border are faced with the prospect of increased illegal activity on their property and in their communities. Witnesses testified that more work needs to be done to ensure communication amongst all levels, ensure that community concerns are addressed, greater use of technology, and using data to examine what is and what is not working.

#### H.R. 5065 - Bottles and Breastfeeding Equipment Screening Act

**Status**: Approved by the House Homeland Security Committee on 9/13 **Summary**: This bill directs the Department of Homeland Security to: notify air carriers and Transportation Security Administration (TSA) security screening personnel of TSA's 3-1-1 Liquids Rule Exemption guidelines allowing baby formula, breast milk, and juice on airlines; and include training on all special procedures under TSA's travel guidelines for TSA security screening personnel.

#### H.R. 5346 - Securing our Agriculture and Food Act

Status: Approved by the House Homeland Security Committee on 9/13

**Summary**: This bill amends the Homeland Security Act of 2002 to direct the Assistant Secretary for Health Affairs to carry out a program to coordinate Department of Homeland Security (DHS) efforts related to defending the food, agriculture, and veterinary systems against terrorism and other high-consequence events that pose a high risk to homeland security. #### H.R. 5460 - First Responder Access to Innovative Technologies Act

**Status**: Approved by the House Homeland Security Committee on 9/13 **Summary**: This bill amends the Homeland Security Act of 2002 to direct the Federal Emergency Management Agency (FEMA) to implement a uniform process for reviewing applications that contain explanations to use grants provided under the Urban Area Security Initiative or the State Homeland Security Grant Program to purchase equipment or systems that do not meet or exceed any applicable national voluntary consensus standards developed under the Post-Katrina Emergency Management Reform Act of 2006.

#### H.R. 5728 - Cuban Airport Security Act of 2016

Status: Approved by the House Homeland Security Committee on 9/13

**Summary**: To prohibit scheduled passenger air transportation between the United States and Cuba until a study has been completed regarding security measures and equipment at Cuba's airports, to amend title 49, United States Code, to clarify the role of the Secretary of Homeland Security regarding security standards at foreign airports, and for other purposes.

#### H.R. 5843 - United States-Israel Cybersecurity Cooperation Enhancement Act of 2016

**Status**: Approved by the House Homeland Security Committee on 9/13 **Summary**: To establish a grant program at the Department of Homeland Security to promote cooperative research and development between the United States and Israel on cybersecurity.

#### H.R. 5859 - Community Counterterrorism Preparedness Act

**Status**: Approved by the House Homeland Security Committee on 9/13 **Summary**: To amend the Homeland Security Act of 2002 to establish the major metropolitan area coun-

terterrorism training and exercise grant program, and for other purposes.

#### H.R. 5877 - United States-Israel Advanced Research Partnership Act of 2016

**Status**: Approved by the House Homeland Security Committee on 9/13 **Summary**: To amend the Homeland Security Act of 2002 and the United States-Israel Strategic Partnership Act of 2014 to promote cooperative homeland security research and antiterrorism programs relating to cybersecurity, and for other purposes.

#### H.R. 5943 - Transit Security Grant Program Flexibility Act

**Status**: Approved by the House Homeland Security Committee on 9/13 **Summary**: To amend the Implementing Recommendations of the 9/11 Commission Act of 2007 to clarify certain allowable uses of funds for public transportation security assistance grants and establish periods of performance for such grants, and for other purposes.

#### House Homeland Security Committee - Full Committee Hearing - September 14 Shutting Down Terrorist Pathways into America

**Summary**: This hearing examined DHS's capabilities to identify and track foreign fighters and other bad actors attempting to enter the US. The hearing also looked at how DHS shares intelligence across the components ranging from border security intelligence, aviation threats, refugee, asylum, and student visa vetting and how this is then shared with outside stakeholders to prevent attacks. Chairman McCaul expressed concerns with the security standards at last point of departure airports abroad, in that at some airports seem to only employ a minimum standard, putting the U.S. at risk. Additionally, he expressed concerns with the screening of airport personnel, as well as the ability to screen refugees entering the U.S. Witnesses stated that the screening process for refugees to enter the U.S. is much more rigorous than that of many other countries. Ranking Member Thompson additionally asked about the process to screen incoming refugees, as well as whether the security screening process in place from flights from Cuba are adequate enough. Additionally, he discussed the concerns that have arisen over the security of our elections from cyber threats.

**Summary**: To reauthorize and improve the Juvenile Justice and Delinquency Prevention Act of 1974, and for other purposes. Federal programs to prevent juvenile delinquency and provide services to young offenders would be reauthorized through fiscal 2022. #### House Oversight Committee - National Security Subcommittee Hearing - September 14 Radicalization in the U.S. and the Rise of Terrorism

**Summary**: This hearing examined the scope of radicalization, and assess what steps can be taken to mitigate the rise of terror via lone wolf attacks and organized terrorist plots. Witnesses testified that more needs to be done to share information among all levels in law enforcement. As was discovered during the investigation following the Orlando attack, the suspect had been previously under investigation by the FBI, while state and local law enforcement had no knowledge of such investigation. Additionally, this Members and witnesses discussed what restrictions, if any, should be in place for those who are on a terrorist watch list from purchasing a firearm.

#### S. 2763 - Holocaust Expropriated Art Recovery Act of 2016

#### Status: Approved by the Senate Judiciary Committee on 9/15

**Summary**: This bill allows civil claims or causes of action to recover artwork or other cultural property unlawfully lost because of persecution during the Nazi era, or for damages for the taking or detaining of such artwork or cultural property, to be commenced within six years after the claimant's actual discovery of: (1) the identity and location of the artwork or cultural property, and (2) information or facts sufficient to indicate that the claimant has a claim for a possessory interest in the artwork or cultural property that was unlawfully lost.

#### S. 3155 - Foreign Cultural Exchange Jurisdictional Immunity Clarification Act

#### Status: Approved by the Senate Judiciary Committee on 9/15

**Summary**: This bill amends the federal judicial code with respect to denial of a foreign state's sovereign immunity from the jurisdiction of U.S. or state courts in commercial activity cases where rights in property taken in violation of international law are in issue and that property, or any property exchanged for it, is: (1) present in the United States in connection with a commercial activity carried on by the foreign state in the United States, or (2) owned by an agency or instrumentality of the foreign state and that agency or instrumentality is engaged in a commercial activity in the United States.

#### S. 3270 - Elder Abuse Prevention and Prosecution Act

#### Status: Approved by the Senate Judiciary Committee on 9/15

**Summary**: To prevent elder abuse and exploitation and improve the justice system's response to victims in elder abuse and exploitation cases.

#### H.R. 5484 - State Sponsors of Terrorism Review Enhancement Act

Status: Approved by the House on 9/12.

**Summary**: To modify authorities that provide for rescission of determinations of countries as state sponsors of terrorism, and for other purposes.

#### H.R. 5104 - BOTS Act

#### Status: Approved by the House on 9/12.

**Summary**: This bill prohibits: (1) intentionally using or selling software to circumvent a security measure, access control system, or other control or measure on a ticket seller's Internet website that is used by the seller to ensure

equitable consumer access to tickets for any given event; or (2) selling any ticket in interstate commerce knowingly obtained in violation of such prohibition.

## H.R. 5351 - To prohibit the transfer of any individual detained at U.S. Naval Station, Guantanamo Bay, Cuba

#### Status: Approved by the House on 9/15 (244-174).

**Summary**: This bill prohibits U.S. agency funds from being used until the earlier of the enactment date of an Act authorizing FY2017 appropriations for military activities of the Department of Defense (DOD) or January 1, 2017, for the transfer or release to or within the United States, its territories, or possessions or to any foreign country or entity of an individual detained at Naval Station, Guantanamo Bay, Cuba.

## <u>S.Res. 566</u> - Supporting the goals and ideals of National Domestic Violence Awareness Month Status: Approved by the Senate on 9/15

**Summary**: A resolution supporting the goals and ideals of National Domestic Violence Awareness Month, commending domestic violence victim advocates, domestic violence victim service providers, crisis hotline staff, and first responders serving victims of domestic violence for their compassionate support of victims of domestic violence, and expressing the sense of the Senate that Congress should continue to support efforts to end domestic violence and hold perpetrators of domestic violence accountable.
