Latest News

- The House and Senate are not in session this week, and are expected to return the week of April 24. When they return, they will have until April 28 to pass some form of spending bill to keep the federal government operating. It has yet to be determined what the bill will look like and how it may affect law enforcement and homeland security programs.
- On April 10, Elaine Duke was sworn in as the next Deputy Secretary for the Department of Homeland Security. You can view the press release here.
- ONDCP Director Announcement According to news reports, President Trump is expected to announce shortly the selection of Congressman Tom Marino (R-PA) as the next Director of the Office of Drug Control Policy. Marino is a former prosecutor, who authored the Transnational Drug Trafficking Act, which was signed into law by President Obama in 2016.
- Rocky Mountain HIDTA Supplement Report Recently, the Rocky Mountain HIDTA released a supplement to it's September 2016 report showing updated additional information on the use of marijuana in Colorado. This report shows trends/statistics in marijuana use, marijuana related incidences, and other marijuana related statistics. You can view the supplement report here.
- DOJ Crime Reduction Task Force Last week, Attorney General Sessions sent out an update memo on the new DOJ Task Force on Crime Reduction and Public Safety initiative. Task Force subcommittees will undertake a review of existing policies in all areas to advance the Administration's goal of reducing violent crime and other priorities. The Task Force has been directed to hold a National Summit on Crime Reduction and Public Safety, so that they can learn from federal, state, local, and tribal law enforcement agencies, victims' advocacy organizations, and community advocacy organizations about how they can best support and replicate successful local violent crime reduction efforts. - DOJ Initiatives to Advance Forensic Science and Help Counter the Rise in Violent Crime The Attorney General announced that upon the expiration of the National Commission on Forensic Science, the new Task Force on Crime Reduction and Public Safety Subcommittee on Forensics will undertake an initiative to increase the capacity of forensic science providers, improve the reliability of forensic analysis, and permit reporting of forensic results with greater specificity. - ICE Declined Detainer Weekly Report Last week, ICE released its third declined detainer report on non-Federal jurisdictions that do not honor detainers issued by ICE to that jurisdiction. Due to intense criticism by state and local law enforcement officials regarding the inaccuracy and mischaracterizations of information within the previous reports, ICE will be suspending the future release of these reports until further review of its data collection methodology is completed. When the Obama administration launched a sweeping policy to reduce harsh prison sentences for nonviolent drug offenders, rave reviews came from across the political spectrum. Civil rights groups and the Koch brothers praised Obama for his efforts, saying he was making the criminal justice system more humane. But there was one person who watched these developments with some horror. Steven H. Cook, a former street cop who became a federal prosecutor based in Knoxville, Tenn., saw nothing wrong with how the system worked — not the life sentences for drug charges, not the huge growth of the prison population. And he went everywhere — Bill O'Reilly's show on Fox News, congressional hearings, public panels — to spread a different gospel. "The federal criminal justice system simply is not broken. In fact, it's working exactly as designed," Cook said at a criminal justice panel at The Washington Post last year. **Continue reading** here.

I want to urge you to consider the potentially dangerous effects of the legalization of marijuana in Connecticut. I lost my beloved son, lan James Eaccarino, on Sept. 10, 1996 to drugs. Ian was a college student and a talented athlete. He had a bright future ahead of him, but it turned out he had started using marijuana at the age of 14. By the time he was 18, he was using cocaine, and at age 19, heroin. We are now more commonly finding out that youth are starting with marijuana and moving on to other drugs. In lan's sophomore year of college, he called me in tears, begging for help. He was using heroin and didn't know how to stop. Only a few months later, lan died in his sleep of a drug overdose. When I found him, my cries for help were heard two blocks away. Ian was only 20 years old.

ICE suspends weekly detainer report of uncooperative law enforcement agencies Star Tribune | David Chanen

After weeks of pushback alleging inaccuracies, U.S. Immigration and Customs Enforcement is suspending its weekly list of law enforcement agencies it claims do not cooperate with requests to detain immigrants living here illegally. Hennepin County Sheriff Rich Stanek said his office was advised Monday by ICE Regional Field Office Director Scott Baniecke that they will not publish a Declined Detainer Outcome Report for the week of Feb. 18-24, citing inaccuracies from the previous three weeks — including one Stanek publicly challenged. Stanek is demanding an apology for what he called "a pattern of significant errors." **Continue reading** here.

Senate Judiciary Committee - Full Committee Markup - April 3

Nomination of Neil Gorsuch, to be an Associate Justice of the Supreme Court

Status: Approved by the Senate Judiciary Committee on 4/3

Senate Homeland Security Committee - Full Committee Hearing - April 4

Fencing Along the Southwest Border

Summary: This hearing examined the issue of fencing along the southwest border. Witnesses testified that fencing can play an important factor in preventing and deterring individuals from illegally crossing the southern border, along with stemming the tide of drugs and human trafficking. However, a border wall alone is not the solution to the problem. A mix of increased use of technology, manpower, and fencing are all needed to help secure the border more effectively. Additionally, eminent domain concerns will be an issue with building a wall on private land, and will be very costly, and take time to work its way through legal challenges.

House Judiciary Committee - Crime Subcommittee Hearing - April 4
Oversight of the DEA & ATF

Summary: This oversight hearing of the DEA and ATF examined current activities and priorities of the agencies, along with how they have addressed management concerns and past controversies. DEA Administrator Rosenberg explained what the agency is doing to combat the current opioid epidemic, and actions to stem the flow of drugs into the U.S. Additionally, he explained steps that the agency has taken in response to various GAO and IG reports outlining misconduct and mismanagement concerns within the agency, and how they have sought to remedy those problems. In particular, Administrator Rosenberg was asked how the agency has changed their practices with regards to the use of confidential informants. ATF Director Brandon also discussed changes within his agency, and new policies to ensure greater transparency, and prevent future abuses.

House Oversight Committee - Full Committee Hearing - April 4
Use of Confidential Informants at ATF and DEA

Summary: This hearing examined the ATF and DEA's use of confidential informants. Concerns have been raised by the DOJ IG regarding past mismanagement of the CI program, lack of accountability, and lack of transparency. The DOJ IG found incomplete and inaccurate tracking of money or amounts paid to CIs at both agencies. Committee members asked DEA to turn over its new policy on its use of CIs, however, the agency declined at the advise of DOJ, of which the Committee then issued a subpoena for the information. The agencies stated that they have since corrected past mistakes with the program, and have instituted new policy changes to ensure greater accountability.

House Education & Workforce Committee - Full Committee Markup - April 4

H.R. 1808 - Improving Support for Missing and Exploited Children Act of 2017

Status: Approved by the E&C Committee on 4/4.

Summary: Amends and improve the Missing Children's Assistance Act.

H.R. 1809 - Juvenile Justice Reform Act of 2017

Summary: Reauthorizes and improve the Juvenile Justice and Delinquency Prevention Act of 1974.

House Homeland Security Committee - Border Security Subcommittee hearing - April 4

Defeating a Sophisticated and Dangerous Adversary: Are the New Border Security Task Forces the Right Approach? Summary: This hearing examined the DHS' counter network strategy and the recently authorized border security joint task forces that aim to better coordinate efforts to secure the border. Members questioned witnesses on duplication of task force activities, and whether some responsibilities could be combined with others, or if the current model made more sense. Witnesses explained that they feel the various task forces have worked well, and that coordination has improved, doing a better job on identifying threats and sharing of intelligence than they did in the past. Additionally, resource issues for the Coast Guard was discussed, with some members of the Committee concerned with proposed

Senate Homeland Security Committee - Full Committee Hearing - April 5 Improving Border Security and Public Safety

Summary: This hearing heard testimony from Secretary Kelly on border security issues. The issue of the border wall was discussed, where Kelly stated a wall will not be built along the entire southern border, but a combination of a wall where it makes geographic sense, increased border agents, and increased use of sensors and other technology. Kelly was also asked about the practice of examining the phones and electronics of individuals going through customs, as well as what is being done to stop the flow of drugs from coming over the border.

House Appropriations Committee - Labor HHS Subcommittee Hearing - April 5 Federal Response to the Opioid Abuse Crisis

Summary: This hearing examined the federal response to the nation's opioid abuse epidemic, and how federal funds are being coordinated to combat this problem. It was noted that arrests alone will not solve the problem, and short term treatment also will not work. Evidence based treatment is important to combating the epidemic, along with the importance of resources for state prescription drug monitoring programs, which has been effective at decreasing the supply of prescription opioids. Additionally, members of the Committee heard about best practices from state efforts, and learned about what has worked and what has not.

House Judiciary Committee - Full Committee Markup - April 5

H.R. 1842 - Strengthening Children's Safety Act

Status: Approved by the Judiciary Committee on April 5

Summary: Amends title 18, United States Code, to include State crimes of violence as grounds for an enhanced penalty when sex offenders fail to register or report certain information as required by Federal law, to include prior military offenses for purposes of recidivist sentencing provisions.

H.R. 1761 - Protecting Against Child Exploitation Act

Status: Held by the Judiciary Committee on April 5

Summary: Amends title 18, United States Code, to criminalize the knowing consent of the visual depiction, or live transmission, of a minor engaged in sexually explicit conduct.

H.R. 1862 - Global Child Protection Act

Status: Approved by the Judiciary Committee on April 5

Summary: Amends title 18, United States Code, to expand the scope of certain definitions pertaining to unlawful sexual conduct.
