- The House and Senate are in session this week. Much of the attention will be on the public
  hearing by the Senate Intelligence Committee where Attorney General Jeff Sessions will testify regarding the investigation into Russian hacking and other issues. Additionally, appropriations and authorizing committees of jurisdiction will hold hearings on the FY 2018 spending
  requests for various federal agencies, including the Department of Justice and FBI.
- The House Homeland Security Committee plans on holding a markup on a reauthorization measure for the Department of Homeland Security. The House Homeland Security Committee has been active over the past couple of years taking a piecemeal approach to reauthorize certain parts of the department, with the hopes of an overall comprehensive reauthorization measure. The Major County Sheriffs of America sent a letter (here) in support of the legislation to the committee.
- Last week, the House and Senate Homeland Security Committees heard from DHS Secretary Kelly on the department's FY 2018 budget request, as well as priorities for a potential reauthorization of the department. Additionally, the House Judiciary Crime Subcommittee held a hearing examining the various DOJ grant programs. Much of the attention however was on the Senate Intelligence Committee hearing, where former FBI Director James Comey testified.
- **DHS Grants Allocations** Two weeks ago, the Department of Homeland Security released the fiscal year 2017 grant allocations for the State Homeland Security Grant Program, UASI, and others. A couple items to highlight: there will be 33 high risk urban areas funded under UASI, up from 29; permittable use of Stonegarden funds will be expanded to include 287(g)-related border enforcement functions; and due to the late issuance of the allocations, there will be a shorter application submission period. - **DEA Fentanyl Handling Guidelines** On June 6, The Drug Enforcement Administration released an updated video and guidelines for local law enforcement and first responders on the dangers of fentanyl exposure. Sheriff Mike Chapman of Loudoun County, VA was in attendance of the announcement on behalf of the Major County Sheriffs of America. # Supreme Court to rule on cellphone location privacy Politico | Josh Gerstein

The Supreme Court has agreed to decide how much privacy Americans are entitled to in cellphone tracking data that can reflect their location and movement. The justices announced Monday that they will rule on whether a search warrant should be required before authorities obtain information from mobile-phone companies that can reflect a user's approximate movements in the past. The method traces which phone tower a device was connected to and which set of antennas on the tower were used. The case was brought by a man convicted in a string of armed robberies in Michigan based on "cell site location information" the FBI obtained with a court order, but without a warrant requiring probable cause. **Continue reading here.** 

#### Veterans Affairs Chief Says Medical Marijuana Drawing Interest as Potential Treatment The Wall Street Journal | Michael Bender

Dr. David Shulkin, the secretary of the U.S. Department of Veterans Affairs, said Wednesday that medical marijuana may benefit veterans dealing with post-traumatic stress disorder, and encouraged lawmakers to debate the issue. "There may be some evidence that this is beginning to be helpful, and we're interested in looking at that," Dr. Shulkin told reporters at the White House when asked about medical marijuana. Federal law prohibits the agency's doctors from prescribing medical marijuana, he said. Top officials from the American Legion, an advocacy group for veterans, urged the Trump administration last week to reclassify marijuana and allow research into whether cannabis could reduce suicides among troops and help veterans dealing with PTSD. **Continue reading here.** 

# California could become a sanctuary state for marijuana Fox 5 San Diego | CNN Wire

California lawmakers are trying to protect the marijuana industry by establishing California as a sanctuary state for pot. A bill moving through the state legislature would prohibit state and local police from assisting federal agents who target marijuana businesses that are legal according to state law, unless those agents have a court order. "The reason for this is because the present administration in Washington is very unpredictable," Assemblyman Reggie Jones-Sawyer, a Democrat from Los Angeles and the author of the bill, told CNNMoney. "This is protecting the rights of Californians." The bill passed the state Assembly 41-33 last week. Most Democrats supported the bill, and most Republicans opposed it. **Continue reading** here.

#### H.R. 495 - Protection of Children Act

Status: To be considered by the House Judiciary Committee on 6/14

**Summary**: This bill amends the William Wilberforce Trafficking Victims Protection Reauthorization Act of 2008 to eliminate the special repatriation requirements for unaccompanied alien children (UAC) who are nationals or residents of a country contiguous to the United States. (The same removal requirements are applied to all UACs who are not victims of a severe form of trafficking in persons and who do not have a fear of returning to their country of nationality or last habitual residence.) An immigration officer who finds an inadmissible UAC at a land border or port of entry shall return the child to his or her country of nationality or of last habitual residence. (Currently such authority is discretionary.) The Department of State is authorized to negotiate agreements between the United States and other countries for the repatriation of children. (Under current law, State is required to negotiate agreements between the United States and countries contiguous to the United States for the repatriation of children.)

Senate Homeland Security Committee - Full Committee Hearing - June 6

The Department of Homeland Security Fiscal Year 2018 Budget Request

Summary: This hearing heard from DHS Secretary Kelly on the FY 2018 budget request. Questions revolved around cuts to the grant programs, immigration enforcement, cyber security, and other issues. Regarding the grant programs, Senators expressed concerns with the Administration's desire to cut the various homeland security grant programs. Secretary Kelly stated that since 9/11, where these programs were crucial to allow state and local jurisdictions to ramp up purchasing of equipment and capabilities to prevent future attacks, however, since then we have matured in our capabilities, and with budget constraints, state and local jurisdictions need to take on a greater share of the financial burden to fund their anti-terrorism capabilities.

House Oversight Committee - Full Committee Hearing - June 7

Fast and Furious, Six Years Later

Summary: This hearing examined any new information or evidence that may exist with regards to the Fast and Furious investigation. Members of the committee expressed continued concerns that information regarding the investigation continues to be withheld from the committee. The Department of Justice declined to appear before the committee on this matter citing ongoing litigation.

House Homeland Security Committee - Full Committee Hearing - June 7

Department of Homeland Security Reauthorization and the President's FY 2018 Budget Request

**Summary**: This hearing heard from DHS Secretary Kelly on the FY 2018 budget request with many of the same questions as the Senate hearing the previous day. Questions revolved around cuts to the grant programs, immigration enforcement, cyber security, and other issues. Regarding the grant programs, Members expressed concerns with the Administration's desire to cut the various homeland security grant programs. Secretary Kelly stated that since 9/11, where these programs were crucial to allow state and local jurisdictions to ramp up purchasing of equipment and capabilities to prevent future attacks, however, since then we have matured in our capabilities, and with budget constraints, state and local jurisdictions need to take on a greater share of the financial burden to fund their anti-terrorism capabilities.

House Judiciary Committee - Crime Subcommittee Hearing - June 8
Oversight of Department of Justice Grant Programs

**Summary**: This hearing examined the various justice grant programs, including those administered by OJP, OVW, and the COPS office. Members of the committee discussed how the grants have worked, and what could be improved. Some members also discussed ways that some of the programs could be streamlined, and address concerns of potential overlap. Additionally, oversight of the grants was discussed to ensure money is not wasted, and that all requirements of the grant is being met. Mr. Hanson was asked about the equipment working group, and he stated that the working group has been reassembled and they are looking at the previous administrations policy regarding so-called "military" equipment.

Senate Intelligence Committee - Full Committee Hearing - June 8 Former Director James Comey, FBI

**Summary**: This hearing heard from former FBI Director James Comey regarding the agency's investigations into the Clinton email investigation, the investigation into Russian collusion and interference into the 2016 election, and his ultimate termination as Director. Director Comey admitting to leaking of his own memos detailing his conversations with President Trump, admitted that while there was not a direct request to drop the investigation into Michael Flynn, that the conversations were inappropriate, and also an inappropriate request by former AG Lynch to not label the investigation into former Secretary Clinton an investigation.

Joint Economic Committee - Full Committee Hearing - June 8
Economic Aspects of the Opioid Crisis

**Summary**: This hearing examined the economic affects of the current heroin and opioid crisis. Witnesses testified to the devastating effects that this crisis has had on families, communities and local economies. Ohio Attorney General Mike DeWine stated that his state is facing the worst public health crisis in our lifetime. Congressman Tiberi stated that developments in the sourcing, cost of production, potency, and retail delivery have spread the supply of both legal and illegal addictive drugs across the country. Additionally, the addition of fentanyl have made deaths and overdoses ever more prevalent.

House Homeland Security Committee - Transportation Subcommittee Hearing - June 8 How Can the United States Secret Service Evolve to Meet the Challenges Ahead

**Summary**: This hearing examined the U.S. Secret Service, and how the new director plans to address past concerns and reform the agency. The hearing focused heavily on how the agency plans to address moral issues, misconduct, recruitment, and overall staffing. Additionally concerns surrounding overtime for the department was a top concern among members of the committee. Director Alles stated much of the problems that the agency has faced stemmed from a leadership failure that manifested into other problems and misconduct. IG Roth also addressed inefficiencies within the Secret Service, and the need to update systems and ensure that the different databases they have are capable of communicating with each other.

#### H.R. 2213 - Anti-Border Corruption Reauthorization Act of 2017

**Status**: Approved by the House on 6/7; Reported as amended by the House Homeland Security Committee on 5/16 **Summary**: Customs and Border Protection could waive its polygraph requirement when recruiting certain military and law enforcement officials to work as Border Patrol agents under this legislation. The bill is intended to help the agency comply with President Trump's executive order directing CBP to hire 5,000 more Border Patrol officers.
